THE 08/04/2023 PAYMENT TOTALED \$14,308,359 ON 95,389,062 UNITS. GASLOG LTD DID NOT HAVE SUFFICIENT CURRENT OR ACCUMULATED EARNINGS FOR THE 2023 TAX YEAR. THEREFORE, THE 08/04/2023 DISTRIBUTION SHOULD REDUCE THE BASIS OF THE OUTSTANDING GASLOG LTD COMMON UNITS FOR THE 2023 TAX YEAR.**
