THE 02/16/2024 PAYMENT TOTALED \$23,847,266 ON 95,389,062 UNITS. GASLOG LTD DID NOT HAVE SUFFICIENT CURRENT OR ACCUMULATED EARNINGS FOR THE 2024 TAX YEAR. THEREFORE, THE 02/16/2024 DISTRIBUTION SHOULD REDUCE THE BASIS OF THE GASLOG LTD COMMON UNITS FOR THE 2024 TAX YEAR.
