THE 2/16/2024 PAYMENT TOTALED \$23,847,266 ON 95,389,062 UNITS. GASLOG LTD ESTIMATES IT WILL NOT HAVE SUFFICIENT CURRENT OR ACCUMULATED EARNINGS FOR THE 2024 TAX YEAR. THEREFORE, THE 2/16/2024 DISTRIBUTION SHOULD REDUCE THE BASIS OF THE OUTSTANDING GASLOG LTD COMMON UNITS FOR THE 2024 TAX YEAR. GASLOG LTD WILL CONTINUE TO UPDATE AND REFINE THIS ANALYSIS AND WILL PROVIDE UPDATES TO THE WEBSITE AS THEY ARE AVAILABLE.

COMMON UNITHOLDERS WHO RECEIVED THE 2/16/2024 DISTRIBUTIONS MUST REDUCE THE BASIS IN THEIR UNITS BY \$0.250000 PER UNIT.
