14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ A CASH DIVIDEND WAS PAID TO SHAREHOLDERS OF GASLOG LTD PREFERRED UNITS ON 10/02/2017. THE 10/02/2017 PAYMENT TOTALED \$2,515,625 ON 4,600,000 SHARES OF PREFERRED UNITS. GASLOG LTD ESTIMATES THAT THE COMPANY WILL NOT HAVE CURRENT OR ACCUMULATED EARNINGS FOR THE 2017 TAX YEAR. THEREFORE, THE 10/02/2017 DISTRIBUTION SHOULD REDUCE THE BASIS OF THE OUTSTANDING GASLOG LTD PREFERRED UNITS FOR THE 2017 TAX YEAR. GASLOG LTD WILL CONTINUE TO UPDATE AND REFINE THIS ANALYSIS AND WILL PROVIDE UPDATES TO THE WEBSITE AS THEY ARE AVAILABLE.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ THE BASIS OF PREFERRED UNITS MUST BE REDUCED BY 100% OF THE TOTAL DISTRIBUTION RECEIVED DURING 2017. PREFERRED UNITHOLDERS WHO RECEIVED THE 10/02/2017 DISTRIBUTION MUST REDUCE THE BASIS IN THEIR UNITS BY \$0.546875 PER UNIT.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶ THE 10/02/2017 DISTRIBUTION AMOUNT WAS \$0.546875 PER OUTSTANDING SHARE OF PREFERRED UNITS. THE ADJUSTED TAX BASIS OF EACH SHARE OF GASLOG LTD'S PREFERRED UNITS IS THEREFORE TO BE REDUCED BY \$0.546875. SHOULD THE ABOVE REDUCTION EXCEED THE AMOUNT OF ADJUSTED BASIS, THE EXCESS IS TO BE TREATED AS A CAPITAL GAIN.
