14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ A CASH DISTRIBUTION WAS PAID TO HOLDERS OF GASLOG LTD'S PREFERRED UNITS ON 10/03/2022. THE 10/03/2022 PAYMENT TOTALED \$2,515,625 ON 4,600,000 UNITS. GASLOG LTD ESTIMATES THE COMPANY WILL NOT HAVE SUFFICIENT CURRENT OR ACCUMULATED EARNINGS FOR THE 2022 TAX YEAR. THEREFORE, THE 10/03/2022 DISTRIBUTION SHOULD REDUCE THE BASIS OF THE OUTSTANDING GASLOG LTD PREFERRED UNITS FOR THE 2022 TAX YEAR.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ THE BASIS OF GASLOG LTD PREFERRED UNITHOLDERS MUST BE REDUCED BY 100% OF THE \$0.546875 DISTRIBUTION PER PREFERRED UNIT.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶ THE 10/03/2022 DISTRIBUTION AMOUNT WAS \$0.546875 PER OUTSTANDING GASLOG LTD PREFERRED UNIT. THE ADJUSTED TAX BASIS OF EACH SHARE OF GASLOG LTD PREFERRED UNITS IS THEREFORE TO BE REDUCED BY \$0.546875. SHOULD THE ABOVE REDUCTION EXCEED THE AMOUNT OF ADJUSTED BASIS, THE EXCESS IS TO BE TREATED AS A CAPITAL GAIN.
